The Awards offer finalists the chance to gain personal satisfaction and the prestige of being part of an elite group who unequivocally represent the State's best in vocational education and training.

Winners from the Tasmanian Training Awards (in aligned categories) have the opportunity to compete with other states and territories to be named the best in Australia at the 2019 Australian Training Awards which will be held in Brisbane, in November.

# School-based Apprentice/Trainee

## Part I: Eligibility and conditions of entry

The School-based Apprentice/Trainee of the Year Award is presented to a student who is undertaking a Certificate II or above qualification as a School-based Apprentice. The Award recognises the student's commitment to their formal studies at school, and in the workplace.

The School-based Apprentice/Trainee of the Year Award is sponsored by Consumer, Building and Occupational Services - CBOS.

### Eligibility

Nominees must:

- be a permanent resident of Australia
- be undertaking/completing a Certificate II or above qualification through a School-based Apprenticeship or Traineeship
- have a Contract of Training registered with Skills Tasmania
- be still enrolled at school
- be nominated by their school, registered training provider or employer and be endorsed by all three parties.

The winner of this category is automatically nominated for the 2019 Australian Training Awards and will compete at the national level.

### Conditions of entry

Nominees must:

- apply for only one category and must meet all eligibility criteria. When an application does not meet the eligibility requirements, it will not be considered by the judging panel
- agree to notify the Tasmanian Training Awards immediately should there be a change in your circumstances with regard to your school/college attendance, training or employment
- be prepared to attend interviews as required and, if selected as a finalist, attend the presentation dinner in Hobart on Friday, 6 September 2019
- abide by the decisions of Skills Tasmania whose decision shall be final on all matters pertaining to the award. No correspondence or justification for any decision shall be required of Skills Tasmania
- acknowledge that should you win the School-based Apprentice/Trainee of the Year Award you must be able to represent Tasmania at the 2019 Australian Training Awards in Brisbane. You will be required to take leave from work or study commitments for the entire week from 17 November to 22 November, including the awards dinner on Thursday, 21 November. Travel, meals and accommodation costs for the Australian Training Awards are covered
- be prepared to undergo all preparations that Skills Tasmania considers necessary for the 2019 Australian Training Awards, including a professional development workshop in October
- acknowledge that by entering the Awards, finalists and winners agree that Skills Tasmania may use non-confidential details, profiles, training details and/or photographs/videos for any publicity purpose pertaining to vocational education and training including, but not limited to, Tasmanian Training Awards, Australian Training Awards and the promotion of vocational education and training and workforce development

## Part 2: Application and selection processes

### How to complete your application

- Review the eligibility requirements to ensure you meet the eligibility requirements and are nominating in the correct category.
- Read the conditions of entry and agree to these conditions.
- Complete the application at Part 4. Your application needs to include the nomination form, a short overview and responses to all selection criteria. Note a word limit applies:
- Applications are to be in 12 pt. Arial font and must be within the word count applicable for the overview and each criterion.
- Up to five (5) single A4 page attachments are permitted (this is optional). These pages can include testimonials, copies of certificates, etc.
- Should you win the School-based Apprentice/Trainee of the Year Award your original application will be submitted to the Australian Training Awards for consideration. You will not submit a new application or have the opportunity to rewrite it so make the most of the word limit and ensure you are putting your best application forward!
- Applications can be submitted via email, post or hand delivered. Keep a copy for your reference. Do not bind or laminate your application.
- If you are submitting your application via email please name the document with your name and the award you are applying for. For example; Sam Smith – ASbA. Once you have completed your nomination form, overview and selection criteria, and collated any supporting documentation, attach all documents in an email to [jacqui.maclaine@skills.tas.gov.au](mailto:jacqui.maclaine@skills.tas.gov.au)
- The overview and selection criteria should be the focus of your application; however any relevant evidence may be provided so long as it does not exceed the word and page limits. No multimedia items or discs will be accepted with applications.

### Selection of finalists

- Applications for this award close on Friday, 7 June 2019 at 5:00 pm. No late applications will be accepted.
- Applications will be assessed against the selection criteria to shortlist applicants.
- All applicants will be advised in writing as to whether they have been shortlisted.
- Skills Tasmania reserves the right to reject an application, or rescind shortlisting, in the case of any non-compliance.
- Shortlisted applicants for the School-based Apprentice/Trainee of the Year Award will be required to attend an interview in Hobart the week beginning Monday, 22 July.
- The decision of the judging panel is final and no appeals will be entered into.

### Privacy notice

The information provided by you in this application will be used by Skills Tasmania for the purpose of administration, judging and general communication in regard to the Tasmanian Training Awards and Australian Training Awards (should you win your category). Provision of this information is essential to determine your eligibility for consideration for an award. The information will be stored securely.

### **7 June 2019 (5:00pm)**

Applications close (no late applications will be accepted).

### **11 June – 4 July 2019**

Applications are shortlisted.

Applicants are notified by email as to whether they have been selected for an interview.

### **Week beginning Monday, 22 July**

School-based Apprentice/Trainee of the Year finalists are interviewed at Skills Tasmania offices, Level 4, 4 Salamanca Place Hobart. To remain eligible, finalists must attend this judging process.

### **6 September 2019**

Finalists attend the Tasmanian Training Awards Presentation Dinner at Wrest Point Hobart.

### **17-22 November 2019**

Individual award winners (in aligned categories) attend Australian Training Awards Week in Brisbane.

## Tasmanian Training Awards gala dinner

The 2019 Tasmanian Training Awards will be announced at a gala dinner on Friday, 6 September in the Tasman Room at Wrest Point Convention Centre in Hobart. Over 500 guests are expected to attend this special evening.

School-based Apprentice/Trainee of the Year finalists each receive two complimentary tickets to attend the dinner (one for themselves and one for a guest). Additional tickets will be available for family and friends to purchase from July until bookings close on 30 August (unless sold out sooner). It is a requirement that all finalists be present at the dinner.

## Australian Training Awards

The Australian Training Awards are the peak, national awards for vocational education and training, recognising innovation and excellence in the training sector. The awards are hosted by the Australian Government and are the culmination of the state and territory awards.

Winners from the Tasmanian Training Awards (in aligned categories) will have the opportunity to compete with other states and territories to be named the best in Australia at the Australian Training Awards. Consider any skills you have developed through your training, such as:

- What have you been able to tell others, students, mates etc about your training?
- What do you like about working in a team setting?
- What traits do you think are important to positively influence others?

### Criterion 3: Ability to be an Ambassador (representative) for training in Australia

(Limit 400 words)

Tell us about:

- Provide examples where you have taken a leadership role inside or outside of school.
- What other activities have you been involved in where you have been a representative?
- How would you describe the quality of your training?

### Criterion 4: Other qualities and pursuits

(Limit 400 words)

You may wish to include information about:

- Have you had to address and challenges that have impacted on your training?
- When have you been required to use initiative either in your training, your personal life or your workplace?
- What other qualities or activities do you feel would be useful in your role as School-based Apprentice/Trainee of the Year?
- What other community or work experience have you had?
